

INTERLOCAL COOPERATIVE PURCHASING AGREEMENT

COPY

This agreement is entered into by the undersigned municipal corporations of the State of Washington.

It is the purpose of this agreement to provide for the cooperative purchase of materials, supplies and equipment by the parties to this agreement when determined by the authority of the participating agency to be in the best interest of such party. This agreement is entered into under the authority of the interlocal cooperation act, Chapter 39.34 RCW.

IT IS AGREED UPON BY BOTH PARTIES AS FOLLOWS:

1. **TERM** - The term of this agreement in respect to each party to this agreement shall commence on the date of execution of the agreement by such party and shall remain in effect until terminated by such party as provided in paragraph 5 of this agreement.
2. **COOPERATIVE PURCHASE** - The determination of whether or not any party to this agreement shall purchase materials, supplies, or equipment under the terms and conditions of any purchase contract entered into by another party under a statutory bidding procedure shall be made by the legislative body of the party desiring to make such purchase.
3. **FINANCIAL RESPONSIBILITY** - Each party shall remain financially responsible for the payment of the purchase price of all materials, supplies, and equipment purchased and received by such party under the terms of this agreement.
4. **OWNERSHIP** - Title to all items purchased by any party to this agreement shall remain the name of such party.
5. **TERMINATION** - Any party to this agreement may terminate its participation in the agreement by giving a written notice of such intent to terminate.
6. **ADMINISTRATOR** - The Chief Executive officer of the party initiating the purchase of material, supplies, or equipment under the provisions of this agreement shall be the administrator of such purchase transactions.

7. **LIMITATIONS** - The parties shall not jointly acquire property or jointly budget funds under the authority of this agreement but shall restrict their actions to providing in bid proposals and specifications appropriate language to authorize and permit other parties to the agreement to purchase such materials, supplies, and equipment under the terms and conditions of the purchase contract awarded by such party.
8. **RECORDS** - A copy of this agreement shall be filed and maintained by each party to this agreement.
