Personnel Committee: The Personnel Committee met on January 4, 2017, and hired three new entry-level firefighters.

STAFF BUSINESS

Operations Report:

Chief Cole Reported that we were up 189 calls in December ending 2016 with 13,861 calls. We were up 549 transports from 2015 to 2016, which is by far the largest increase we have experienced.

Cole reported that we continue to feel the effect of the influenza epidemic. Our crews are experiencing extremely long waits at the hospitals keeping units out of service and we have had an increase in sick time.

We have lost two part-time employees, one to Seattle Fire and the second chose another career path. With the hiring of three new entry-level positions, that leaves another three holes in our part-time schedule. We have hired ten new part-time recruits who will start shadow shifts February 1, 2017.

The Everett Community College (EvCC) Fire Program has been suspended indefinitely. Spring and possibly fall classes have been cancelled. This could pose a real problem for our part-time program as 50% of our recruits come from EvCC.

Our three new full-time hires will be effective March 1, 2017. They will start the academy at North Bend May 4, 2017, and graduate July 28, 2017.

We are still working out a few minor issues with the electronic time sheets. January has been a month of training and February we will run electronic and paper time sheets side by side.

NEW BUSINESS

SNOPAC Outage: Chief Cole reported that on January 11, 2017, we experienced a significant outage in the emergency dispatch system leaving us at level two operations for approximately five hours. The outage was correlated to the installation of a hardware upgrade from New World.
