DISCUSSION

Chairperson Christoffersen shared some concerns raised regarding the RFA Plan.

Commissioner Term: There was some confusion on the length of time the voting and non-voting Commissioner positions are to serve on the RFA Board. District Attorney Grant Weed shared that the RFA Plan states the voting position is a four year term and the non-voting position is a two year term. The RFA Plan was approved by the Board of Commissioners and voters and was adopted by the full RFA Board. Weed stated the Plan cannot be changed without voter approval.

Commissioner Vote in lieu of Absence: It was questioned whether the non-voting Commissioner can-vote-in-the absence-of-the-voting-Commissioner-or-if-the-third-Commissioner-can-step-in-in-the absence of one of the appointed commissioners. District Attorney Grant Weed shared that there is no language in the RFA Plan that would allow for any Commissioner other than the appointed voting member to vote. Weed shared that as previously discussed with City Attorney John Walker, the voting member has the option the call or skype in to meetings.

Meeting Compensation: It was again asked if the non-appointed Commissioner is compensated for attending RFA meetings. District Attorney Weed shared the Snohomish County Fire District 12 Board of Commissioners appointed the voting and non-voting Commissioner positions to the RFA Board. The third Commissioner my chose to attend an RFA meeting but will not be compensated for attending. Weed explained RCW 52.140.10 authorizes payment for attendance of a FD12 meeting

for conducting FD12 business. The statue does not apply for attending an RFA meeting since the non-appointed Commissioners attendance is not required and is neither a FD12 meeting nor conducting FD12 business.

Chief McFalls – Stated he forwarded the 2-7-2018 minutes which includes the motion made by Ross and seconded by Cook accepting option three for the initial RFA operating governance model of four Council members and one Commissioner.
