**A RESOLUTION ADOPTING AND REPLACING PRIOR MARYSVILLE FIRE DISTRICT
POSITION JOB DESCRIPTIONS**

WHEREAS, the Regional Fire Authority known as the Marysville Fire District provides fire suppression, emergency medical, fire prevention and other non-emergency services within the corporate boundaries of the City of Marysville and Snohomish County Fire District No. 12; and

WHEREAS, Marysville Fire District operates a “combination” department, consisting of full-time and part-time firefighters; and

WHEREAS, The Board of Directors desires a comprehensive set of general guidelines describing the job duties for all District employee positions, including physical requirements, workplace conditions, and other aspects of public employment; and

WHEREAS, these job descriptions apply to all positions of the District. In cases where these job descriptions conflict with an applicable state or federal law or an individual written employment agreement or collective bargaining agreement, the terms of the law or agreement will control.

WHEREAS, the job descriptions attached to this Resolution as Attachment #2 and incorporated herein by this reference, are general guidelines for the District’s current positions including physical requirements for each position. They are not intended to be a contract, expressed or implied, or any type of promise or guarantee of specific treatment upon which employees may rely, nor a guarantee of employment of any specific duration; and

WHEREAS, the District distributed draft copies of the attached job descriptions to representatives of the IAFF Local #3219 that represent District Firefighters and Battalion Chiefs and to District Leadership who has incorporated comments thus received into the version attached as Attachment #1 to this Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS FOR THE MARYSVILLE FIRE DISTRICT, A REGIONAL FIRE AUTHORITY, AS FOLLOWS:

1. The Marysville Fire District Board of Directors hereby approve and adopt the job descriptions attached hereto as Attachment #2 and incorporated herein by this reference. Said job descriptions are adopted as the District’s position descriptions and shall be applicable to all employees, appointed and elected District officials unless preempted by state or federal law or in conflict with an existing employment agreement or collective bargaining agreement.
2. The job descriptions attached hereto as Attachment #2 replaces all previous versions of job descriptions.
