The District reserves the right to reject any or all bids, and reserves the right to waive any irregularities in the bids or bidding procedure.

The successful bidder must be a factory authorized distributor to sell the equipment specified and proposed.

Contract/purchase documents shall be included with all bids and shall conspicuously include;

- reference to this document as part of the contract, and
- any and all exclusions or exceptions to the specifications, and
- total price of the contract with and without sales tax, and
- total price for each option, and
- shipping costs if applicable, and
- price of any alternate or optional proposals.

Documentation shall be submitted, with the bid, describing in detail the qualifications of the bidder to sell, service, install and maintain power cots and cot loading systems.

Documentation shall be submitted, with the bid, describing in detail the proposed system(s), including but not limited to: diagrams; drawings; capacities; load, raise, and lower times; and construction specifications.

This bid shall be subject to RCW 39.34, Interlocal Cooperative Agreement, wherein other governmental agencies may purchase off this bid request at the terms and prices indicated herein.

The Fire District reserves the right to reject a bid based on unacceptable provisions of a bidder's contract. No Exceptions.

It shall be the responsibility of the bidder to assure that their proposal arrives at the proper location by the time indicated. Late proposals, electronic, or telephone bids will not be considered.

SPECIFICATIONS FOR STRYKER SYSTEMS

Current Operations

The Marysville Fire District, through diligent research and study, has previously determined that a single and particular design and manufacturer of cot power loading and raising systems sufficiently met the needs of the fire department to provide the necessary safety and ease of operation to its employees and citizenry. As such, Marysville Fire District has selected and currently utilizes the Stryker Power Pro 2 Cots and Stryker Power Load Systems. In order to ensure compatibility in use and operation, it is the intent of the Marysville Fire District to award a bid to purchase additional and only such systems.

General

It is the intention of the Marysville Fire District to immediately purchase one or more Stryker Power Load Systems and Power Pro Cots. This bid award may be used to purchase additional systems by the Marysville Fire District or other agencies, for up to 3 years post award.

All components shall be new and or current manufacturer design. Used, surplus, and discontinued equipment are unacceptable.

The general description of the systems shall be; Stryker 6507 Power Pro 2 High Configuration Cot, Stryker MTS Power Load System with Floor Plate.

All exceptions must be listed on a separate sheet entitled "SPECIFICATION EXCEPTIONS". Each exception must be clearly documented and explained. All bid data sheets must be completely filled out and returned with the bid in a sealed envelope addressed to:

Successful Bidder The Bidder who has been selected by the fire district to supply components

Fire District The Marysville Fire District. (Purchaser)

Specifications

A. Identification:

All major components and accessories shall be clearly identified with permanently affixed nameplates stating the make, model and serial number. Other pertinent information such as capacities, pressure, voltage, currents, etc. are to be indicated in the proper manner.

B. Documentation & Instructions:

One complete documentation package shall be delivered with each system containing information on operation, maintenance, troubleshooting and replacement parts, unless otherwise agreed to by the Fire District at the time of order.

A documentation package shall include, at a minimum, an Operator's Instruction and Maintenance manual, recommended spare parts list, warranty information and any start-up/warranty registration forms.

The Operator's Instruction and Maintenance Manual for the system shall be as detailed as possible, outlining all operation and maintenance instructions. The manual shall include detailed illustrations along with a complete parts listing for all illustrated components. Warnings and safety precautions shall be identified clearly in the manual.

Appropriate tags and warning labels shall be affixed where necessary for safety and ease in the operation of switches and controls.

C. Testing & Warranty:

All equipment shall be factory assembled, thoroughly tested and backed by a minimum of oneyear limited warranty covering parts and labor. The warranty period shall be a minimum of one year regardless of the hours accumulated on the equipment. The warranty shall commence once the fire district accepts the system.

Available warranty extensions and service contracts shall be included as options.

D. Shipment & Delivery:

The system shall be suitably prepared for motor freight transport.

Vendor agrees that all components ordered for the installation of this system shall be delivered between August 1, 2025 and August 15, 2025 or not more than 16 weeks from purchase notification to the vendor.

E. Acceptance and Payment:

The Fire District shall accept the system once the fire district is satisfied that all portions of the agreement between the vendor and the fire district have been completed to the satisfaction of the fire district. This shall include, but is not limited to, satisfactory training and orientation of fire district personnel and adequate display of proper operation. Once the fire district accepts the system, full payment shall be made within normal payment processing constraints, generally no longer than 45 days.

F. Authorized Service Center:

The vendor shall provide with this bid the name, address and phone number of the nearest factory authorized service center. The service center must be factory authorized to perform warranty work, preventative maintenance, and on-going service.

G. New Components Only:

All equipment shall be new and of current design and manufacture. Used or refurbished equipment is unacceptable.

J. Contract Award

The Fire District reserves the right to reject any or all bids deemed by the Fire District to be unresponsive.

The final contract will be awarded to the lowest responsible bidder most closely meeting the departments attached specifications, based upon the criteria of the fire district. Bid award, if any, will be made within sixty (60) days of the bid opening.

The Fire District also reserves the right to waive any informalities, irregularities and technicalities in procedure. The Fire District is not bound to accept the low bid.

Bidders shall submit manufacturers standard purchase contract with bid proposal, for the review of the Fire District.

Pricing submitted shall be honored by the vendor for a period of 12 months.

The Fire District reserves the right to extend the period of time the contract shall be valid for up to three years, allowing the Fire District to purchase additional items as deemed necessary. The Fire District may elect, at its sole discretion, to negotiate the purchase cost for additional units after a period of one year, based upon negotiated price adjustments following the Consumer Price Index and annual adjusted rate of inflation for emergency equipment.
