RESOLUTION 2018B-9

DECLARING SURPLUS AND TRANSFER OF OWNERSHIP OF:
NINETY-TWO 50' SECTIONS OF 1 ¾" FIRE HOSE

WHEREAS, Marysville Fire District owns ninety-two 50' sections of 1 ¾" fire hose, Identification Numbers as attached, (Equipment); and

WHEREAS, Marysville Fire District no longer has a need for the Equipment; and

WHEREAS, Washington State Law provides in Chapter 39.33 RCW authorizes the "sell, transfer, exchange, lease or otherwise dispose of any property, real or personal, or property rights, including but not limited to the title to real property, to the state or any municipality or any political subdivision thereof, or the federal government, or a federally recognized Indian tribe, on such terms and conditions as may be mutually agreed upon by the proper authorities"; and

WHEREAS, Skagit Community College, (Agency), has indicated a need and desire to acquire such Equipment so as to improve Fire Department Education Operations, providing for emergency fire suppression training and education to surrounding communities; and

WHEREAS, the Agency has a very limited annual budget allotment for the Firefighter I training and certification program, and,

WHEREAS, the Marysville Fire District currently, and has regularly in the past, hired individuals trained and certified as Firefighters and EMTs at area Community Colleges, and

WHEREAS, the sale of used fire hose has historically received minimal interest, reflecting little to no cash value as disposed assets,

NOW, THEREFORE BE IT RESOLVED, that the Marysville Fire District Board of Directors hereby adopt the following:

1. Marysville Fire District declares the Equipment to be surplus to the district's needs.
2. The Board of Directors directs staff to transfer ownership of the Equipment to the Agency at no cost, as is – where is, with no warranty of particular use.
3. Marysville Fire District staff is directed to finalize an agreement, including waiver of liability, transfer of ownership, and any and all other documents necessary to effect the completion of transfer to the Agency of the Equipment.
